
From this position, Starr also controlled the Buffalo-Huron railroad depot which would prevent the British from reinforcing against the Fenian Army by train. Starr's men busied themselves with ripping up railroad tracks and cutting telegraph wires to further frustrate Crown attempts at a counterattack. O'Neill and his force crossed shortly after Starr and established a defensive positions extending from Fort Erie to Frenchman's Creek. O'Neill originally intended to move due west and seize the town of Port Colborne – considered the most likely assembly point for Crown forces in the greater Niagara area and a key rail and logistics center. Scout reports coming back to O'Neill indicated that while Crown forces were gathering in Port Colborne, a sizeable force of experienced British regulars was massing to his northwest in the vicinity of Chippawa; combined strength of the Port Colborne and Chippawa forces was estimated at 3.000 men (with supporting artillery). O'Neill quickly understood that the British intended to execute a double envelopment – a "pincer movement" against the Fenians, by launching simultaneous attacks from Port Colborne and Chippawa against Fort Erie. O'Neill was faced with the daunting task of single-handedly defeating an enemy that outnumbered him nearly 3 to 1. He decided upon a bold course of action. Assessing the Port Colborne force, largely inexperienced militia, as the weakest element, he would feint an attack from Fort Erie against the

stronger force at Chippawa. Anticipating that the British would interpret this as his main attack and reinforce Chippawa with the Port Colborne units, he would then turn southwest, ambush the reinforcements and move into the town of Port Colborne unopposed. He would then be in an excellent position to defeat any subsequent attacks from the stronger Chippawa units.

On the evening on 01 June, O'Neill began his diversionary move north towards Chippawa. As he had predicted, the British began moving the units from Port Colborne to reinforce. At about 0300 hrs on the morning of 02 June, O'Neill stopped short of Chippawa and turned his army west, marching to a small village called Ridgeway where he prepared to ambush the British coming from Port Colborne. Miscommunication on the part of the Crown forces facilitated O'Neill's plan, as the actions of the Port Colborne commander were not properly synchronized with the forces at Chippawa. The Port Colborne forces were also poorly supplied with ammunition, with most soldiers carrying only 60 rounds apiece with them. O'Neill had portions of Starr's command as a security element in front of his positions. The intent was to have this screen engage the Port Colborne forces and then withdraw



thereby luring them into O'Neill's ambush. The plan worked well and by 0800 hrs on 02 June, ten companies worth of the Queen's Own Rifles (QOR) had fallen into the trap. Suspecting a potential mounted attack by the Fenians, the QOR formed into defensive squares and soon broke ranks under a bayonet assault by O'Neill's men. Crown casualties at Ridgeway were 18 dead, 75 wounded and 6 captured. Fenian losses were 7 killed and 17 wounded. Concerned with maintaining an escape route back to the United States and unsure of the most recent disposition of the British force at Chippawa, O'Neill then proceeded back to Fort Erie. He was confronted there by the British forces which were massing on the position from the north and northwest. By this point, the US government had sealed the border with Canada, ensuring the O'Neill's force would receive no additional support. Being low on ammunition, realizing that he would receive no further reinforcements from Buffalo and having no idea of the status of Spear's planned attack from Vermont, O'Neill negotiated a truce with Crown officials. British and Canadian prisoners were released and O'Neill began to plan his withdrawal back across the Niagara. US officials allowed a canal boat to be towed across the river to evacuate O'Neill and his men. At 0200 hrs on 03 June, the Fenians left Canada for their short journey back to US soil - the war had lasted three days. Or had it? On 06 June, Spear launched his assault on Lower Canada from St. Albans, Vermont. Capturing several towns, including St. Armand and East Stanbridge, the Fenians anticipated that the Irish population of Montreal would support by rising up in revolt against the British; this did not happen. Approximately 10,000 Canadian militiamen reinforced British troops in Montreal and British warships sat in the St. Lawrence River, prepared to bombard the city. Spear withdrew his force back to Vermont, only to be greeted by US officials who confiscated the Fenian weapons. The Fenian Invasion of Canada had ended.

What did William Randall Roberts's scheme to free Ireland really achieve? For his exploits at the Battle of Ridgeway, O'Neill gained a temporary popularity among Irish nationalist circles in the US and was elected to the Presidency of the Fenian Senate. He, Spear and their men received virtually no punishment for their actions from US officials. O'Neill would attempt two other raids into Canada – one in 1870 and another in 1871. These raids did not approach the scale of the 1866 undertaking and both failed dismally. On 06 June 1866, as Brigadier General Spear and his 2,000 Fenians crossed the border into Canada, the US government negotiated a settlement with the British government. In exchange for \$15 million in British reparations for support of the Confederacy during the American Civil War, the US government would enforce the

Neutrality Act of 1818 and prevent further Fenian incursions into Canada. This explains why Spear's army had their weapons confiscated by US officials upon the return to Vermont. In light of these events, it might be said that the country the benefited the most from the Fenian effort to free Ireland was the United States.


